PROJECT REPORT FOR: SOUTHERN CALIFORNIA BORDER HIV/AIDS PROJECT

Rosana Scolari reporting:

Programmatic/Dissemination:

- Abstract on HIV services at SYHC accepted for the NAUC Conference in Miami – March-April 2003
- Abstracts submitted to APHA and US/Mexico Border Health Conference. SPNS, CASA and HIV Nutrition Counseling Services.
- Outreach services in SD County may be discontinued.

Evaluation:

- Quarterly reports (July 02-September 02) were distributed to program partners on 1/27/03. We discussed a decrease in data collection during the fall/winter of 2002. Program partners identified two main causes for the decrease. First, the fall/winter is traditionally a period of low client enrollment and decreased HIV testing. Second, the additional burden caused by the medical chart review impacted their ability to collect SPNS modules.
- Starting February 2003 we plan to pilot the use of Access databases to enter and track HIV testing information. The evaluation coordinator will provide in-depth T.A. to each of the sites to facilitate the development of a HIV testing database that will both meet the needs of the SPNS evaluation and the site specific issues. A total of four databases will be created and piloted by March 2003.
- New staff trainings: On 1/22/03 the new HIV Prevention Coordinator at Family Health Centers was trained on the SPNS evaluation measures. He will be responsible for coordinating SPNS activities at this site. We expect an increase in data collection from this site in the near future. On 1/29/03 three Title III staff from San Ysidro Health Center were trained on the Treatment Adherence form.

ARIZONA

Steve Trujillo reporting:

Trainings:

Dr. Carmichael made available for the collaborators his schedule for clinics at the CHCs for 2003.

The AZ AIDS ETC is coordinating with Sunset Clinics to provide the training on HIV and Nutrition to their staff on February 26th and training to providers on HIV Medications Update that afternoon. Robert Castrillo is speaking to Mary Castillo and Dr. Wang to have 2 nurses from Sunset shadow at SIA.

Robert Castrillo extended an invitation to Dr. Thomas to attend HIV Citywide Grand Round on T-20 February 20th.

The AZ AIDS ETC extended an invitation to all ABHAC MDs and RNs to attend a rural provider training on HIV at the U of A on March 6, 2003.

Out Reach Activities:

Yuma – YCHD in collaboration with Yuma AIDS Network sponsored two events for World AIDS Day one in Yuma and the second in San Luis, AZ. The events were walks and candle light vigils. In December project collaborators participated in El Dia del Campesino that attracted more than 4,200 people primarily farm-workers. Their information booth saw around 2,100 people. YCHD is in the process of planning for National Condom Week with collaborators and providers in Yuma. Continue to plan house parties.

Two new groups were identified Yuma Q (social network) and Queer Yuma (Advocacy) and will explore ways to work together.

In December YCHD counseled and tested 120 people and there were no positives.

Sunset Clinics and YCHD are developing contracts with Dr. Thomas (ID physician) to refer and coordinate patient care. YCHD contract with Dr. Thomas is expected to be in place by mid-February.

Santa Cruz – Mariposa Community Health Center and its youth programs participated in World AIDS Day activities. MCHC brought in a HIV positive speaker as part of the community activities. Cesar Grijalva participated in the radio program during World AIDS Day. Outreach efforts continue to occur in the established areas of the community. The use of

Mariposa Clinic counseled and tested 25 people in December for HIV and enrolled one new patient.

Cochise – Dr. Garcia shared that CCHD participated in World AIDS Day activities in Douglas and in Bisbee, AZ. Since December 1st fell on a Sunday churches (6) in the communities addressed HIV in their sermons. CCHD secured 5 panels from the Names Project and displayed a panel in each of their sites.

December 5th the Southern Arizona HIV Consortium met in Douglas and invited Dr. Carmichael to speak medical staff from Agua Prieta and Naco Mexico were present.

December 11th Dr. Garcia presented in Agua Prieta, Mexico to students, educators and interested parties on HIV/AIDS and services in Arizona (Douglas, Bisbee, etc.)

December 18th Dr. Garcia and case manager Eunice Parks presented AIDS 101, universal precautions and prevention to staff of Cochise County Handicap Association.

Dissemination Activities: Tony Estrada presented outcome data to ABHAC Project collaborators at the January 3, 2003 meeting.

Project Enrollment: Mariposa Community Health Center enrolled one new participant. Cochise County Health Dept. enrolled one new participant and SIA enrolled one new patient into the project.

Local Evaluation: The Annual Health Provider Assessment were conducted at the CHCs and returned to Impact Consultants.

Veronica Salcido-Harding reporting:

- **PROGRAMMATIC:** Outreach activities continue. This week during our HOWs meeting Eduardo discussed how he received a phone call from a partner of one of clients who he had tested 2-3 months prior (negative results). He inform Eduardo that a week prior during a hospital stay he was diagnosed with both HIV and one of the Hepatities. Eduardo immediately referred him to the New Department of Health's Early Intervention Nurse. This is evidence that even though this individual may have been seroconverting during his initial test with the HOW, rapport had been established to the point that he phone Eduardo.
 - Semi-annual report has been completed and sent to HRSA GMO.
 - Abstract for both USMBHA and APHA have been completed.
 - Preliminary discussions with Betsy Davis, RN Independent consultant has taken place regarding development of HOW's curriculum.
 - Southern Area Health Education Center has scheduled Internet training for Providers to effectively search the internet for reliable HIV/AIDS sites. The training will also be offered to CdV staff.

- **LOCAL EVALUATION:** (Michelle Valverde)
 - We received official notice of the approval of the IRB continuation application.
 - We completed the requirements for the APHA abstract and sent them to Ahmad Saleem Ahmad.
 - I followed up with Marguerite in regard to the Barriers module. We had a conversation via telephone and I was able to refer to my notes.
 - We discovered inconsistencies in the documentation of risks on our local module 6. We corrected the problem for future cases and Yvonne and Jennifer went through all of the previous cases back to the beginning of the project. Tim has been very supportive in helping us to correct the data file.

EL PASO

John Wiebe reporting:

- We submitted an abstract on mental health for APHA, and made plans to present at the social work conference in Albuquerque and the Border Health

Association Meeting in San Diego.

- Time 2 data collection is ongoing.
- We have a new research assistant, Isaac Ortega, helping with the project. Isaac is a bilingual UTEP Psychology graduate, and he is applying for our Master's program in the fall. He will help with data management initially and then move to patient interviewing.
- We are in the process of identifying discrepancies between the information in the multi-site data file and our own recruitment numbers. It appears that we have data from a number of subjects that have somehow not made it to Oklahoma. We will keep Tim abreast of any developments in the process.
- Since the dissemination meeting in D.C., we discovered that El Paso is the only site with the longitudinal collection of the risk factors module as part of our evaluation plan. Thus, we'd like to withdraw our data request form and focus on local data for the depression project. However, we do still have local depression data that could be used to validate other mental health indices if others are interested in such an approach.

Announcements: David Barney concluded by reporting the Abstracts for APHA are in and the Dissemination Page has been updated.

The Research and Evaluation Center has negotiated three gigs on the OU server providing extra web space which enables the inclusion of lengthy reports on the Internet.

Dr. Barney now has a course available on the The University of Oklahoma – Faculty web site [Teaching Program Evaluation](#). The course is available for anyone interested.

Tim Brittingham provided Change Form C for review, however a number of the participants had not received the changes in their e-mail, and discussion was deferred.

Sustainability was addressed at the Grantee Meeting in January, and the subject was brought up at the conclusion of this conference call. Sustainability is considered a key issue for the grantees, and Dr. Barney suggested that participants limit the length of individual presentations during conference calls to five minutes so that time would be available to examine this issue. No one objected to this solution.
